

# Walkers before wheels and cyclists ahoy

Your views please on the desirability (or otherwise) of a trial designating the Waldringfield to Martlesham, Woodbridge Bye-Road, Fishpond Road and Sandy Lane as 'Quiet Lanes'.

Recent increases in fast vehicle and cycle traffic along rural lanes are threatening or even dangerous to walkers, riders and those emerging from their driveways. Also since the Deben river wall has been breached below Howe's Farm, walkers must divert to the Woodbridge and Fishpond roads. But several people whom I have asked say they are afraid to walk those lanes because of cars, vans and even bicycles apparently assuming right-of-way and expecting pedestrians to get onto the verge or even up a bank.

Quiet Lanes, as piloted in Norfolk, Kent and Jersey, are now authorised with appropriate signs by the Department of Transport.



## The concept of quiet lanes

The aim is not simply traffic calming or reduction; rather it is to encourage more considerate and safe roadway sharing plus conservation of rural tranquillity. Although Suffolk led with the automatic 30 mph limit in most villages, our County is said to have been 'timid' over Quiet Lanes but initial indications are that our local authorities, Suffolk Coast and Heaths' AONB Unit and others may welcome a trial with a possible view to a wider network if there is good evidence of community consensus and benefits.

Three websites about Quiet Lanes (links below) emphasise the aim of establishing networks of '...designated minor rural roads intended to pay special attention to the needs of walkers, cyclists, horse riders and the mobility impaired. They are designed to enable users to enjoy country lanes in greater safety and encourage car drivers to respect more vulnerable road users'.

## A Waldringfield Initiative

Having already consulted all the individual property owners beside those three particular lanes, Waldringfield Parish Council now needs to know if this initiative for a trial will have broad community support.

Over 80% of initial responders welcomed the proposal while stressing the fewer signs the better. Some seek a 20 mph speed limit or 'sleeping policemen' but the SCC East Area Highways Manager advises neither is likely.

Obviously persuading drivers and cyclists to expect and respect pedestrians is going to be a real challenge. Setting a good example – Step 1 of leadership! – depends on our individual needs and alternatives:

### Woodbridge Bye-road

The distance via Waldringfield Heath cross roads and then Newbourne Road past the Moon & Sixpence to the T-junction beside Walk Wood is 3.5 Kms compared to 3 Kms on the Bye-road.

Since an average of over 35 mph is usually safe compared to less than 25 mph on the Bye road, the slightly longer route is quicker and most probably saves fuel; but difficult to sign that. Several villagers say they prefer to return from Woodbridge via the prettier Bye Road; if one has time to pause to enjoy the view that will discourage speedsters behind.

### Fishpond Road/Sandy Lane

These are already signed 'Access only', and School Road/Cliff Roads are the quicker, safer and proper route.

## Cyclists

The Tour de France and Team GB's successes are already inspiring an increase in bicycling that most Britons will welcome. And The Times newspaper has clearly 'hit the spot' with its 'Cities Safe for Cycling' campaign. So what about our three lanes as they are already signed as Suffolk Coastal Cycle Route 41, and are clearly a preferred route to avoid motor traffic? Regrettably several local residents, especially the elderly and those with poor hearing, have told me of their alarm from the fast and silent passage of a few pedal cyclists.

There is little point in asking cyclists to ring their bells as most remove them as defunct or bad for speed. So we are asking the Ipswich and other local cycle clubs and also Sustrans what they could recommend. Some cyclists are loathe to call out aloud as they feel that is impolite but I for one would much prefer a recognisable shout from about 30 metres off such as 'Cyclist Ahoy!' or 'Wiggins Beware!'

## Costs and Results

Each Quiet Lane sign on a finger post will cost about £100 to install and 'our' three lanes will need six or seven. If they, our 'example setting', peer pressure and as much good publicity as we can obtain can be shown to reduce fear of walking or riding (horses and pedal cycles) in these lanes, then SCC may well adopt more Quiet Lanes around the AONB and perhaps beyond. Obviously the more widely they are recognised, the more effective they are likely to be.

Firstly we need to gather evidence for before and after effectiveness. Simple vehicle counts and average speed measures might contribute but given the prime aim, what we need to gather is data on increased numbers of confident walkers and riders and reduced incidence of alarm.

Hence my hope that a good number of Waldringfielders will bother to keep a diary of their lane usage and let me have a quarterly report.

# Suffolk Coastal's Core Strategy — Latest Developments

Suffolk Coastal's Local Development Framework Core Strategy (CS) is entering its final stage – Examination in Public. An independent planning inspector, Mr Mike Moore, has been appointed by the Planning Inspectorate to test whether the CS is sound and legal. He held a 'pre-hearing' meeting in July, in which the process was explained, and this included an 'exploratory meeting' in which he investigated whether SCDC had adequately answered some 'concerns' he had about the CS. He decided they hadn't, so he gave them extra time to provide answers.

The Inspector required the following from SCDC:

- A paper showing the calculation behind the 7,590 new dwellings identified by the Council as the full and objectively assessed needs for the District
- A map showing sites of existing and potential alternative green space, where they are, their capacity, suitability and proximity to the development area to the south and east of Adastral Park.

SCDC provided these on 6 August. In fact SCDC didn't show the housing needs calculation required by the Inspector, because their figure of 7,590 houses (since increased to 7,900) is actually what they consider they can deliver – it is a supply figure, not a needs figure (as we have been arguing for years). Instead, they are now claiming the 'need' is for 11,000 houses, as identified in the Oxford Economics Study, which SCDC rejected in 2010. They did provide a map of mitigation sites (alternative green space), but no details of the capacity or suitability of these sites. Most of them had already been designated as being required to meet green space deficiencies that existed before the decision to allocate the extra 2,000 houses at Adastral Park.

Despite the inadequacies of the response, the Inspector has now accepted that the Examination in Public should go ahead. A provisional timetable for the hearings has been published. There will be several of them, and they are all in October and November. Up to date information can be found at SCDC's website:

## Birds and butterflies fluttering about

The Church Field is lovely at the moment with swallows and house martins swooping about, quite a lot of different butterflies and dragonflies around and some interesting wild plants. Look out for the furry clover called hare's foot clover which looks like tiny hare's feet!

Whitethroats and linnets are about as well as ground nesting skylarks, other warblers and grey partridge. Tim Burslem has been doing a great job of mowing the paths and play areas. It is good to see that most people are now keeping their dogs on the lead and the problem of dog mess seems to be lessened (but still present unfortunately).

We have carried out a temporary repair to the basketball hoop which was bent sometime in July. We are very pleased that funding from the SCDC Sportspace Fund has been approved for this work, subject to getting planning permission which we have applied for. If people have further ideas about what facilities might be provided please send in your suggestions.



## Waldringfield community composting

We have been busy on this scheme since May: we have called on nearly eighty households and held 6 composting workshops explaining the three kits that will help people to cope with their food waste. There are people lining up to test all of the kits - and we are keen not to let the momentum drop! We have been encouraged by the level of interest and touched by how often people have invited us in when we are doorstepping and shared their composting and gardening experiences with us.

To strengthen our grant-funding applications we need to earn some money up front. We are therefore hoping to earn 10% of the cost of the kits within the next three months: this is £480.

Our first effort is **Save yourself cooking time!** Come and share a meal in the village hall once a month. Home cooking with local produce.

Book by 6.00 pm. three days in advance – we need a minimum of fifteen people for a meal to be viable, so reserve the right to cancel. We're asking a minimum price of £6 each (barely two cups of coffee!) which will cover the costs of the food and village hall hire – pay what more than that you can afford. Main course and pudding only, with coffee or tea at 50p extra and bring your own other drinks. Children £4.

Friday 28 September 7.00 - 9.30, Monday 22 October 12.00 - 2.30, Thursday 15 November 7.00 - 9.30 . . . and there will be more if these go well!
