Call for Community Volunteers

Many of you will have heard of the very recent sad demise of a muchloved family cat in School Road. Reports suggest that many other family pets have met a similarly unfortunate end in the past and this points to a lack of care and attention by some drivers using that road.

Speed is undoubtedly a factor, if only for the number of concealed and semi-concealed entrances along School and Cliff Roads, giving little time for motorists to take evasive action. However, evasive action, such as a sharp turn of the steering wheel, can lead to perhaps an even worse situation.

The best evasive action is to slow down, especially in an area where there are not only pets, but small children and less mobile adults. If you think that it only takes 18 seconds longer to reach the end of Cliff Road from the School Road speed signs at 20mph than it does at 30mph (and 25 seconds longer than at 40mph), it does not seem anything like an imposition on drivers when measured against a potentially tragic outcome.

Policing rural & village roads is a notoriously difficult task, leading to the introduction of Community Speedwatch — local residents giving up a few hours each month to monitor traffic speed and report repeat offenders to Suffolk Police.

Thanks to generous grants organised by our District Councillor, Susan Harvey, there will be two speed guns and ancillary equipment available for exclusive use by Waldringfield and its neighbouring villages. It is important to get as large a group of volunteers as possible, not only spreading the workload, but also sending a strong message to all that



the local community wants to maintain Waldringfield as a safe and pleasant place for everyone that lives in, works in, goes to school in and visits the village.

Opportunities for juniors at the Sailing Club

In the last edition, we gave information on the Sailing Club's social sailing for 2017. This initiative is in its 3rd year and provides a fortnightly opportunity for adults and children to sail in company, but in a non-racing context. The programme is open to Club members and non-members alike. Social Sailing 2017 kicked off on Saturday 6th May with 20 children and 10 adults getting on the water. The children had breakfast and then split into teams to play water balloon netball - filling balloons from the tap and sailing in relays between the beach and a safety boat where a nervous adult helper held a netball hoop. Some of the older and more experienced junior members also came along with their boats to make sure everyone got a safe sail in what were very windy conditions.

This is proving so popular that we are having to operate a waiting list for the older children, but do contact Jules Rains to find out more.

However, for younger children (up to 7 years old) Cath Hughes is running "Pirates and Mermaids" where there is no restriction on the number of participants. For example, in the first session children set about making a very colourful paper fish and fishing rod, then it was out to the beach for an introduction to a kayak and sailing dinghy to learn some boaty words and boaty bits.

Sandcastles on the beach kept some of the younger children entertained, whilst the older children ventured down to the dinghy park to watch some of the cadet sailors launching for junior sailing. The cost is just £2 per child, which includes breakfast as well as a snack and drink at the end of the morning.

These sessions are run by volunteers together with the help of the parents of the children attending. So please do come prepared to get involved and get wet (at least up to your knees).

Please dress your children in clothes and shoes/wellies/trainers that you are happy for them to get wet. Bring a towel and dry set of clothes to change into and warm coat or fleece just in case the weather turns cold.

Don't forget your buckets, spades and beach toys.

Save Our Swifts




What can be done to stop the decline of the swift population in Suffolk? This problem is highlighted in the Spring/Summer 2017 edition of the Suffolk Wildlife Trust magazine. Edward Jackson reports that swift numbers have almost halved in Suffolk over the last 25 years. He describes the work of the Suffolk Wildlife Trust (SWT) and Suffolk Ornithologists' Group (SOG) in tackling this problem. Their Save Our Swifts (SOS) Project asks everyone to help by reporting 'screaming parties' of swifts, known nest sites and new nest box sites. The information will be added to the map started in 2009 by the Suffolk Biodiversity Information Service (BIS) which shows the distribution of breeding swifts across Suffolk. Our information may help them reverse the decline.

Screaming parties of swifts, especially flying at roof-top level, suggests that nest sights are nearby. This is the information the SOS project needs, rather than sightings of individual swifts. We are asked to send our sightings of screaming parties, together with known nest sites in buildings and new nest boxes, to the BIS website: suffolkbis.org.uk/swift. Let us help to reverse the decline of this charismatic harbinger of Summer.

May I begin by saying that I was very pleased to have been re-elected to represent the people of Martlesham Division at the County Council, and wish to thank all who voted for me, particularly those who helped throughout the campaign. The Conservatives won with a telling majority of 52, thirty of whom are new councillors. The leaders and officers are busily engaged in allocating the various committee chairmanships and membership to councillors. Full Council is on May 25th when appointments will be realised.

Community Speedwatch (CSW) is a national initiative where active members of local communities join with the support of the Police to monitor speeds of vehicles using speed detection devices. Vehicles exceeding the speed limit are referred to the Police with the aim of educating drivers to reduce their speeds. In cases where education is blatantly ignored and evidence of repeat or excessive offences is collated

(even across county borders), enforcement and prosecution follow.

Volunteers receive appropriate training, and are supported by neighbourhood policing team (NPT) staff. As the local scheme covers several villages, with the equipment shared around, it is felt that it is better for volunteers to work in each other's areas, rather than their own, to ensure objectivity and to reduce their concerns about participation.

The scheme aims to cater for the problem of real or perceived speed related offending, and through partnership with the community it is to be used in circumstances that are necessary, justifiable and proportionate in order to reduce death and injury on the roads, improve the quality of life for local communities, reduce the speed of vehicles to the speed limit and increase public awareness of inappropriate speed

Speedwatch activity is not about interfering with neighbours' behaviour; it is a proactive solution to improve the safety and quality of life for everyone in the community.

Update on the Adastral Park Planning Application

In its recent consultation response, Waldringfield Parish Council objected to the Outline Planning Application to build 2000 houses at Adastral Park. The response in full can be found on the village website under *Parish Council/Planning Applications/Adastral Park*

Following the consultation period, members of the Parish Council met representatives from the developer, CEG, together with Suffolk County Council Highways and Suffolk Coastal/East Suffolk Council to discuss further the issues raised by WPC.

Our objections focussed on a number of matters. A selection of these are summarised below along with the outcome of the post-consultation discussions. These show where some progress has been made in response to our objections.

Unsafe and inappropriate access and subsequent severe impact on the local highway network

WPC's objections

We had been particularly concerned that the only access points to the development site during most of the construction period were located at two points on the Ipswich Rd. This would mean that all the heavy construction traffic together with all the traffic generated by the first phases of new residents and services would be using the Ipswich Rd.

We suggested that the plan should be amended so that the proposed direct access onto the A12 was operational before the construction on the development begins, thereby reducing the volume of traffic on the Ipswich Rd.

We also questioned the need for the two access points to remain on Ipswich Rd and suggested that the "western access point" be removed, or at least downgraded to a non-vehicular route.

Post-consultation outcome

CEG agreed to bring forward the direct access onto the A12 so that it is operational before construction on the site begins. SCC Highways and SCDC supported this amendment.

CEG agreed to add to the outline planning application a commitment to downgrade the "western access point" on Ipswich Rd. SCC Highways and SCDC supported this amendment.

Proposed offsite transport mitigation

WPC's objections

The application included a raft of measures to try to "mitigate" the large increase in traffic from the development on the existing road network. Proposals included alterations to the Foxhall Roundabout, including widening the Ipswich Rd approach and increasing the number of lanes approaching from the A12 to 4. *(Continued)*

Update on the Adastral Park Planning Application – 2

Rather than mitigate the effect of the increase in traffic on both the A12 and the Ipswich Rd, the resultant road layout would make it much more difficult for the Ipswich Rd traffic to enter the roundabout.

The application included an "aspiration" to introduce a speed limit of 40mph on the section of Ipswich Rd that is adjacent to the two access points. We commented that the predicted increase in vehicle movements had been undervalued. The undervaluing of vehicle movements could undermine the traffic measures proposed and therefore we recommended extending the proposed 40mph speed restrictions along Ipswich Road to the Heath Crossroads, and that a 30mph speed restriction should be placed on the remaining length of Ipswich Rd into Waldringfield. Failing that, the proposed 40 mph speed restriction should be extended along Ipswich Rd to Waldringfield village.

Post-consultation outcome

WPC were informed that all the proposed mitigation measures will be subjected to an independent safety audit. The concerns regarding accessing the Foxhall roundabout were acknowledged and it was pointed out that as the direct access point to the A12 has been brought forward, phases of the A12 traffic will be held back by the traffic lights at the new A12 junction.

We were also informed that imposing a speed restriction on any road requires the approval of the police as well as highways. SCC Highways appeared to be open to our suggestions regarding extending the proposed speed limits on Ipswich Rd and this will be an ongoing matter for discussion and, for the time being, remains an "aspiration".

On-site Green infrastructure WPC's objections

WPC remains concerned regarding the reduction in the amount of on-site greenspace; however, our ability to change this has been curtailed as it has been approved by Natural England.

Post-consultation outcome

No movement, other than an assurance that an independent consultant will be working with SCDC to examine and assess the on-site greenspace (SANGS) and the Habitat Assessment commissioned by the developer.

Green "buffer" requirements

WPC's objections

The application proposes a green buffer to the southeast of the site. WPC stated that the depth of the buffer is clearly inadequate, given the buffer will provide separation between the development and the Suffolk Coast and Heaths Area of Outstanding Natural Beauty lying to the east of the site. (AONBs have the highest status of protection in relation to landscape and scenic beauty).

Update on the Adastral Park Planning Application — 3

We said that tree planting, including provision of new mature trees should begin before construction starts to ensure that the trees are sufficiently mature from an early stage to provide a more appropriate buffer between the development and the AONB in terms of visual and light pollution screening.

Similarly, we required more detail regarding the perimeter planting along Ipswich Rd. The existing mature trees along the Ipswich Rd boundary are all of a similar age and are likely to die at about the same time, so it is necessary to plant a wide variety of trees - and to continue with this - to ensure the perimeter buffer is maintained over the decades to come.

Post-consultation outcome

The application will include a detailed landscape scheme to improve the density of the southeast buffer. The planting will take place before the construction on the development.

In addition, there will be a landscape management scheme for new mixed planting and replacing trees, when necessary, to maintain the buffer along Ipswich Rd.

Proposed Deben SPA mitigation (off-site)

WPC's objections

SCDC's policy relating to this area, SP20, requires the provision of a raft of measures to mitigate the harmful effect of increased visitor numbers to the Deben Special Protection Area. In the BT Adastral Park application, the contribution towards off-site mitigation measures had been costed out at approximately £300,000. We objected to the fact that no such detailed costings were included in the new CEG application. We also objected to the reliance placed on a yet-to-be adopted "Recreational Avoidance Mitigation Strategy" (RAMS)

Post-consultation outcome

CEG stated that the contribution from the development will be at a level of £150 per dwelling, therefore totalling £300,000.

The distribution of this money will be determined by the RAMS and therefore remains an ongoing matter for discussion.
