This plan is based on the Parish Plan Survey results, both the quantitative data and the comments, together with the outcomes from the Village Meeting held on January 29th. It summarises the issues that have emerged and identifies possible actions. The plan also suggests which group or organisation might wish to take the suggestions forward.

The Action Plan can be seen as a Community wish list and its implementation will rely almost entirely on the support and initiative of volunteers with a particular interest in any of the topics.

The Consultation will be the final step in formulating the Parish Plan.

Taking account of the views expressed through the Survey, the Village Meeting and this Consultation, the Parish Plan Steering Group can then compile a Parish Plan that truly reflects the wishes of the residents of Waldringfield.

The situation is further exacerbated when the existing smaller homes are sold and new owners substantially increase the size of the property. Where possible this imbalance should be addressed. Scale and location of any future development	Q55 was seeking views on the size and placing of any development, rather than the type or size of property. As there was/is uncertainty regarding the BT Adastral Park development the question had 2 parts (a) if the development goes ahead and (b) if it doesn't. In general, residents would like to see more limited development in the Parish if the BT Adastral Park development goes ahead. In that scenario 116 wished to retain the existing village envelope, 18 were in favour of expanding the envelope. 84 people wanted no houses, 120 said single homes in infill, 68 said small groups of 3 or 4 houses, 13 said larger groups of 5+, 114 said conversion of redundant buildings.
