# **REPORT TO THE ANNUAL PARISH MEETING, 12<sup>th</sup> April, 2016**

### **GENERAL CONDITION**

The court is now into its  $18^{th}$  season after total re-construction in 1998. In 2012 a root barrier was inserted along the south-eastern corner, tree root damage was repaired and the surface painted and re-lined. The court is structurally in good condition and should last another 3 seasons before major re-surfacing becomes necessary, which is likely to cost at least £16,000. Moss killer has been applied twice over the past year but professional cleaning has been booked for  $18^{th}$  April to remove all the dead moss from the surface.

## **ANNUAL FINANCES**

- Income for 2015 (court fees and interest less expenses) was £632, this being £203 up on the previous year which has bucked the trend of yearly income decreasing since 2012. This additional income was mainly due to an increase in family membership.
