The District Council is writing to you as part of its formal consultation process regarding BT's current program of proposed public payphone removals which affects a payphone located in your parish. It is the responsibility of the District Council to canvas the opinions of the local community on the removal of payphones and determine whether to veto their removal or not. Should the District Council agree to the removal of the payphone facility, BT does also offer Parish Councils and registered charities the facility to adopt a kiosk, taking ownership of the kiosk for a fee of £1 thereby protecting the heritage of the community.
